ACCEPTANCE DEPOSIT PAYMENT SUBMISSION FORM - SCHOOL YEAR 2026-2027

The Acceptance Deposit payment is required to confirm the offer of a placement at St. Maurice School. This amount, equivalent to approximately 10% of the annual tuition for the student, is payable in cash, by cheque to *St. Maurice School*, by e-Transfer, or by debit/credit card and is required on or before April 24th, 2026. This Acceptance Deposit payment is *not refundable*. If payment is not received, the student will forfeit his/her spot, and it will be offered to the next candidate on the waiting list for that grade level. The remaining balance of the tuition for the school year will be divided into 9 equal monthly payments (September to May), with the first payment due in September and paid to us according to the payment plan option you will select for your family. Where a sibling discount may apply, the remaining total tuition due will be re-adjusted as of October 1st, after we have finalized placements from the waiting lists for Grades 1 to 8. If, after you have paid the Acceptance Deposit amount, you should choose to withdraw your child from St. Maurice School, note that the Acceptance Deposit Payment will not be refunded.
