The tuition fees are subject to change from year to year at the discretion of the School Board for St. Maurice School Inc. All tuition amounts are shown and payable in Canadian Dollars (CAD).

For newly-accepted students, a non-refundable Acceptance Deposit equivalent to 10% of the total annual tuition for the student is required to confirm and reserve the student's spot. Details and payment information will be included on the official Letter of Acceptance emailed to the parent/guardian when a placement is offered.

Tuition payments may be made in full at the beginning of the school year, or on our 9-month payment plan with payment due by the 20th of each month, September through to and including May. Payments may be made by pre-authorized debit (PAD), e-Transfer to tuition@stmaurice.mb.ca, debit card or credit card.

- A surcharge fee of 1% will be applied to all payments made in person with a debit card.
- A surcharge fee of 3% will be applied to all payments made in person with a credit card.
- A fine of \$20.00 will be applied for any pre-authorized debit not honoured by your financial institution, regardless of the reason. This \$20 surcharge also applies to any other fees paid to the school by a cheque or PAD which is returned NSF (for example, for team sports or field trip payments).
- All tuition due for the school year must be paid in full by May 20th, else the re-registration(s) for your child/ren will be revoked for the following school year.

A charitable donation tax receipt for a portion of the tuition fees of St. Maurice School is calculated according to Canada Revenue Agency's information circular #75-23. In part the circular reads:

An official donation receipt will be issued for that portion of a payment which is in excess of the pro-rated "cost per pupil" for academic training. If the family has more than one child in attendance at the school, the "cost per pupil" portion will be multiplied by the number of children in the family.
